It is presented in conjunction with the Handweaver's Guild of America Convergence 2008 in Tampa, Florida.

INFORMATION: All applications must be postmarked by January 19, 2008.

NOTIFICATION

Notices of acceptance will be emailed or post mailed by late February, followed by notification to those not selected.

DELIVERY AND SHIPPING

This will vary depending on which gallery or museum artwork will receive work. You will be contacted by that venue. Generally, artist pays all shipping fees. No entry may be removed before the end of the exhibition, unless item is sold to an out-of-state visitor. All hanging art must be wall ready. We will not wire or rework hanging systems. Please ship your hanger with artwork if it requires more than nails in the wall. Galleries reserve the right not to install works that are not exhibition ready.

INSURANCE AND SECURITY

All artwork on display is covered by the participating gallery insurance. We will not accept galleries without adequate security.

SALES

All work for sale must be retail priced. Galleries may vary in their commissions. You will be notified by selected galleries.

JUDGING CRITERIA

Work is judged on excellence, originality of design, creativity and craftsmanship. Please provide professional quality images.

A \$20 non-refundable application fee is required.

RESTRICTIONS

Artwork must be of original design. No kits or commercial patterns may be used.

METHOD OF ENTRY

Accompany each application with \$20 (non-refundable application fee) check or money order made payable to Atlantic Center for the Arts.

Each artist may submit up to three works for jurying on a CD for either piece work or solo exhibitions. Submit two images per piece: one in detail and one full view. CD's must be labeled with artist's name and

jpegs should be titled: artist's name, title of piece, "full" with size or "detail." Examples:

Jane Doe_Seasons in the Sun Full 24x18

Jane Doe_Seasons in the Sun Detail

Jpegs should be at least 300 dpi and 4" across.

Prints and slides will not be considered.
